ORGANISATIONAL CULTURE

This breakout room features Jo Hickman presenting early findings from action-oriented research that combines coaching sessions with senior leaders and advice staff to explore how cultural and practical changes can improve staff retention.

GROW YOUR OWN ADVICE

This session will spotlight Propel-funded projects exploring "grow your own advice" models to recruit, retain, and develop staff through community-led approaches. Led by Bruna Boscaini of IRMO, the session will feature partnerships showcasing how collaborative, non-extractive structures and shared infrastructure can shift power dynamics and better support workforce development in the advice sector.

STAFF WELLBEING

This workshop offers a space for open discussion around staff wellbeing in the advice sector. Participants will be invited to share their experiences, both the challenges and what has helped, while reflecting on what meaningful support looks like in practice. We will explore the root causes that impact staff wellbeing, and consider how organisations can create environments where staff feel valued and supported.



PAY AND CONDITIONS

This session marks the public launch of two reports on pay, benefits, and working conditions in the advice sector, commissioned to better understand challenges in staff recruitment, retention, and progression. Led by Liz Bayram of Advice UK, the session invites sector leaders and funders to discuss key recommendations, explore collaborative implementation, and identify those interested in shaping the next phase of this work.



DEAF AND DISABLED PEOPLE'S ORGANISATIONS (DDPOS)

This session will share key insights from led-byand-for projects focused on recruiting and
retaining deaf and disabled people in the advice
sector, highlighting both challenges and
successes. Led by Asma Bennani of Disability Law
Service and Inclusion Barnet, the session will offer
practical reflections for organisations aiming to
diversify their workforce and inform funders on
the resources needed to support inclusive
recruitment and progression.


